GENERAL PARTICIPATION CONDITIONS

Article I Event organiser

Maurice Records, spol. s r.o. Bednářská 1025/3
180 00 Prague 8-Libeň, CZECH (hereinafter the organiser)

Article II

Applications and assignment of spaces

1. The application to participate is binding for the exhibitor once sent to the organiser. The organiser decides about the acceptance, shortening or rejection of the application, without having to justify its decision.
2. The organiser sends confirmation of definite allocation of exhibition space to the exhibitor at least 2 weeks before the trade fair, but only if rent was paid by the deadline specified in the invoice. Payment of the entire rent is a condition for handover of the stand, space or table to the exhibitor before the event begins.
3. If the rent is not paid by the deadline specified in the invoice, the exhibitor's delay constitutes a gross violation of its contractual obligation and the organiser is authorised to withdraw from the agreement under the conditions of Art. III(3).
4. In exceptional cases, the organiser reserves the right to change the location or dimensions of the exhibition space, stand or table even after its allocation and confirmation to the exhibitor.

Article III

Rent and exhibition spaces

1. The rent for exhibition spaces, stands and tables is always indicated in the application for participation or in the organiser's letter. Each fraction of a square meter is billed as a whole.
2. The exhibitor cannot pass the allocated exhibition space to a third party without prior written consent from the organiser.
3. If the exhibitor cancels participation before allocation of an exhibition stand or table, the exhibitor will be billed a cancellation fee of CZK 3,000. If the exhibitor cancels participation after allocation of an exhibition stand or table, the exhibitor will be billed a cancellation fee equal to 100% of the amount specified in the order, which the exhibitor is obliged to pay without undue delay.
4. The price includes basic expenses for hospitality during the evening for the exhibitor, if organised.



Article IV

Payment conditions

The exhibitor undertakes to pay the event organiser for all provided fulfilment by the maturity date of the invoice specified in the invoice.

Article V Goods

1. The exhibitor is obliged to indicate the prices of exhibited goods. The exhibitor must secure the goods against theft.
2. The deliver and removal of goods is governed by the organiser's instructions. Handling and storage fees are billed for goods and installation material not removed from the stand or table by the end of the rental period.
3. Goods are taken over exclusively by the exhibitor. If the exhibitor or its representative is not on site, the goods shall be delivered to the allocated exhibition space at the exhibitor's risk.

Article VI

Stand construction and installation

1. The dates for assembly, dismantling and operation hours are designated by the organiser. Exceptions to deadlines are permitted by the organiser at request of the exhibitor's or its representative. The exhibitor or its representative shall pay potential associated extra costs.
2. The official supplier of stands is Maurice records s.r.o. In exceptional cases, the exhibitor may build the stand itself, but only with prior approval from the organiser. If the stand is not built by the official supplier, the exhibitor is fully liable for its activity on the organiser's premises, in particular for the fulfilment of work safety regulations, assembly and dismantling deadlines.
3. The exhibitor is authorised to promote its product only at its own stand or on its own table.
4. All means of presentation outside of the stand or table are subject to approval by the organiser.
5. The exhibitor is obliged to install the exhibited goods before the opening of the exhibition for the public and the exhibited goods must be removed by the exhibitor after the official closing of the exhibition for the public.

Article VII Insurance

The organiser is not liable to the exhibitor or its co-exhibitor for the loss, destruction or any damage to goods, facilities or equipment of the stand, packaging or packaging material, regardless of whether destruction or other damage occurred before, during or after the exhibition. The exhibitor shall conclude insurance for this purpose.

Article VIII Final provisions

1. If the organiser in consequence of unforeseen circumstances ("vis major") cannot commence the trade fair, ensure the event for its entire duration, or part thereof at the entire exhibition ground or part thereof, or at a different location, it shall inform the exhibitor of this immediately. All liabilities arising for the organiser from the concluded agreement on the exhibitor's participation expire. In this case, the exhibitor is not entitled to any claims for compensation of incurred damages. The exhibitor is authorised to withhold a reasonable part of the payments paid by the exhibitor in the meantime.
2. The exhibitor may apply claims from work and services provided by the event organiser to the responsible employee without undue delay, at latest within 48 hours before the end of the event. Otherwise, the right shall expire.
3. Unless stipulated otherwise, the organiser is authorised to exclude the exhibitor from further participation in the trade fair if it violates any provision of these general terms. In this case, the exhibitor is not entitled to any claims for compensation of potential damages and refunding as rent paid in the meantime.

We agree without objections to the conditions specified on the reverse of the application form and also at www.atelierartfest.cz and with the price conditions of the trade fair. We acknowledge the organisers right the increase or decrease the required exhibition space as needed and install exhibits based on the sector classification of the trade fair. The application will not be accepted if the exhibited content does not comply with the trade fair nomenclature. An application without a signature, date and place is invalid!
